


The Marchex, Inc. 2023 Annual Meeting of Stockholders will be held on Thursday, September 28, 2023, at 10:00 a.m. Pacific Time, at Marchex, Inc., 1200 5th Ave., Suite 1300, Seattle, Washington 98101.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote FOR all nominees and FOR Proposals 2, 3 and 3 YEARS on Proposal 4:

- 1. To elect five (5) individuals to serve on the Company's Board of Directors for the ensuing year and until their successors are duly elected and qualified;
- To ratify the appointment of RSM US LLP as the Company's independent registered public accounting firm for the fiscal year ending December 31, 2023.
- 3. To approve, by a non-binding advisory vote, the compensation paid to our named executive officers.
